Facilities' milestone progress in Reentry Initiative

The Reentry Initiative under the Medicaid Transformation Project (MTP 2.0) provides essential health care benefit services for individuals leaving incarceration to ensure a person's successful reentry to their community.

The Health Care Authority (HCA) invited carceral facilities across the state to participate in this initiative. There are three cohorts — groups of participating facilities — that go live at different times. This document lists the facilities by cohort as they move through the program milestones.

- **Milestone 1 Intent to Participate:** The facilities listed here have expressed their commitment and intent to participate in the Reentry Initiative.
- Milestone 2 Capacity Building Application (CBA): The facilities listed here have successfully provided HCA with details on their current capacity to launch the initiative (go live) as well as identified areas where capacity building is needed.

HCA is regularly updating the facilities listed on this document to provide the most up-to-date information about milestone completion. This list is not indicative of a facility's final approved cohort, rather their intended cohort as they work towards a go-live date. Throughout the process, HCA is working collaboratively with participating facilities to help them complete their unique implementation plans and determine their readiness to go live.
