Apple Health and crisis services information

This document provides phone numbers and websites to support your health care needs as you reenter your community after incarceration. There is detailed information about how to access Apple Health (Medicaid) services on the same day of your release or soon after if you are a managed care client or an Apple Health client without a managed care plan. The final section provides details for contacting crisis services.

If you don't know if your Apple Health (Medicaid) plan is a managed care plan or fee-for-service plan, call the Health Care Authority (HCA) at 1-800-562-3022 (Monday – Friday 7 a.m. to 5 p.m.). First choose '3' for an agent; then '1' to check eligibility. You can also call HCA at 1-800-562-3022 if you need help reactivating your benefits.

If you are a Washington Apple Health (Medicaid) client with a managed care plan, you may contact your managed care organization (MCO) using the information in the table below. The Nurse Advice Line will connect you to a nurse who can answer health care questions and help connect you to the care you need. The Nurse Advice Lines are also open after business hours for assistance with your health care benefits.
