

## PROBLEM STATEMENT AND SAFE SUPPLY DEFINED


#### **PROBLEM STATEMENT**

- Drug overdose deaths in Washington continue upward, with almost 3,000 lives lost in 2023.
- From 2023-2024 Washington moved into the top 10 for overdose rate.
- >> One in six deaths involve fentanyl.
- >> There are unmet behavioral health needs, treatment availability does not match demand.

#### Overdose deaths shift to Western states

Between 2023 and 2024, Western states Alaska, Nevada, Washington and Oregon moved into the top 10 for rate of drug overdose deaths. Overdoses increased in 10 mostly Western states despite an encouraging national dip.

Overdose rate per capita



#### SAFER SUPPLY

"Safer Supply" refers to the availability of regulated pharmaceutical options for people with substance use disorder. There are varying degrees of evidence for different models.

- **1. Treatment model:** The strongest evidence base is for hydromorphone and diacetylmorphine as treatment options alongside methadone.
- 2. Drug Supply Alternative model: prescribe a wider range of drugs, including short acting opioids, benzodiazepines, and stimulants, with reduced barriers to access, to reduce overdose risk.





Documented and evaluated benefits across all models include:

- ✓ Decrease in participation in crime
- Less street drug use among participants
- ✓ Increase in social wellbeing
- Access to employment and housing
- ✓ Lower risk of overdose death.

Safer supply can be regulated to mitigate risk of diversion.



Remove barriers to the implementation of a randomized clinical trial of safer supply for people with opioid use disorder in Washington

- >> Researchers, with federal government cooperation, can implement randomized controlled clinical trial (PGT)
- While a RCT has not been done before countries diacetylmorphine and hydrom with RCTs over 20 years ago and demo methadone.



Propose state legislation that establishes a scalable safer supply pilot program

A state general assembly can pass a state law authorizing the establishment of a safer supply pilot program in accordance with certain rules and expectations.

>> In a safer supply program, people are pharmaceutical grade drugs as an alte and deadly illicit market.



Enhance and expand existing harm reduction and substance use disorder treatment services statewide

- >> Invest in provider education on safer supply and harm reduction principles
- >> Integrate harm reduction services and philosophy into treatment programs
- Improve patient autonomy in existing opioid treatment in accordance with updated SAMHSA guidelines include home dosing assessment and mobile delivery
- Increase the number of community-based syringe serv programs



### **PROCESS SUMMARY**

#### **DESK REVIEW OF SAFER SUPPLY RESEARCH**

- >> Relevant studies were identified using terms "safe supply," "prescription opioid agonist," "prescription heroin," and "heroin assisted treatment" and searching academic journals
- Series Series
  - $\gg$  impact on cravings
  - >> changes in use of street purchased/unregulated substances
  - >> neighborhood effects
  - >> quality of life measures of recipients
  - >> impact of treatment on infectious disease incidence and treatment adherence.
- More recent studies evaluate safer supply programs, which expanded significantly in Canada in 2016 and during the COVID-19 pandemic.

#### DATA COLLECTION WITH PRIORITY POPULATION

Setween May 2023 and September 2023, a research team at the University of Washington interviewed 457 people in Seattle who used drugs. The study revealed high acceptability (81% among people who injected opioids) of safer supply programs among people who currently use drugs.

>Most participants (69%) indicated that receiving a regulated opioid supply would be "a lot less risky" than their current supply.


