<ul style="list-style-type: none"> • On July 1, 2018, the Division of Behavioral Health and Recovery (DBHR) will move to join the Health Care Authority (HCA) including 120+ staff; move is not physical at this time; staff will remain in Lacey; will be joining us in the reporting structure; Chris Imhoff will report directly to Sue Birch; where it makes sense, certain reporting and re-org will occur; once org charts get settled we will get them to you (Action Item) • We will be working to figure out how we can bring staff to HCA physically; this is a major task, and something we will be working through in the coming months • Are there any questions? • Gerry Yorioka: North Sound is getting people at clinical level; trying to get them to understand and get along, and make sure the clinical side is being addressed • MaryAnne Lindeblad: There are a couple things we can speak to; Accountable Communities of Health (ACHs) are working on projects, and working through bi directional health and behavioral care; as move toward full integration, making sure practices are more closely linked; what is being provided and by whom • Folks here have been meeting with BH providers to created better linkages; ACHs that are in regions moving to mid adopter in Jan 2019 are getting monies to invest at community level; they will be getting 			

first amount shortly; this is significant; look at ways to build out HER; different providers can be more effective

- Gerry Yorioka: What about Designated Mental Health Professionals (DMHP)?
- MaryAnne Lindeblad: DMHP is a crisis services agency; example of crisis services are those provided by Beacon; 4 of 5 going live in 2019; will continue old BHO and morph into something like Beacon, working with folks who will be detaining; not going to see significant change in that area at first
- MaryAnne Lindeblad: Any other questions on this topic? [No]
- MaryAnne Lindeblad: On the community side, the RFP still active; apparent successful bidder (ASB) has not been announced; bringing 5 regions live; King, Pierce, Greater Columbia, Spokane and North Sound, these are coming live Jan 2019; there is significant work; King and North Sound will do transition year, former BHO may continue with certain responsibilities that over time will occur more with the Health Plan
- There will be a significant lift in 2019; Peninsula will go live 2020; initiating conversations with their commissioners, etc., on what 2020 will look like
- Bob Perna: There are a lot of moving parts on what you just described and understand a RFP is in works; will there be a document that summarizes the parts?
- MaryAnne Lindeblad: When ASBs are confirmed, we can look at creating a document

8. Medicaid Non-Citizens

- Possible change in Public Charge (PC); want folks to understand nothing has changed so far; PC governed by Homeland Security; has been used in past to help folks who trying to gain citizenship status
- They are in a status, if had been receiving TANF, or similar, may have in past prohibited
- DHS has proposed rule making changes, what qualifies for public charge; past include Medicaid, SNAP Medicaid, any kind of state assistance, it would be wrapped in public charge
- This is concerning for us, led conversation with OMB and cross administrations – DSHS Commerce, DOH, other work done by RDA – discussion what change would (impact) in WA
- If change is going to cost less, appears change would have impact of over 100M, with Governor’s lead on Monday, had opportunity to discuss with OFM, concerns what WA impacts would be on hospitals, providers, etc.
- Biggest concern right now is the message; we are hoping regulation has not been passed or released; we are currently in a hold pattern
- Want to relay to families, there are no changes yet; encourage families to apply for coverages, etc.
- Gerry Yorioka: Every summer we have people become citizens, is there a number or trend of new citizens in WA?
- Mary Wood: Don’t know if we have those specific numbers, or if specific to summer; we have not seen changes, it has been pretty flat; if anything, it has ticked down (we can look for data)
- Andrew Busz: Do I understand policy to mean that aid would threaten their ability to be non-eligible to become citizens?
- Mary Wood: Yes – there used to be few benefits, more were excluded; have document put together by Governor’s office that can share (Action)

<ul style="list-style-type: none"> • Quick update since legislative session extended Children’s Mental Health Workgroup (CMHWG) for two more years through 2020; CMHWG was managed/staffed by House; Representative Senn and MaryAnne Lindeblad co-chaired the workgroup; HCA is now staffing • In taking over CMHWG, looking at who will have the responsibility and what that looks like; at least in short term it is Gail Kreiger and her assistant • We are working on agenda setting and what the future looks like • Ann Christian has submitted an agenda topic; looks like already have agenda items and may need to postpone item • Meetings will be in Olympia, four times per year; there is a lot of interest in this group; also interest in infant mental health, schools; Ann’s area if interest is psychosis • Ann do you want to say anything? • Ann Christian: There is now strong research to say that if we are able to identify evidence based model, have ability to prevent full psychosis from presenting, if before actually occurs; want to make sure all resources are available to make this a statewide policy priority; a lot of people don’t know there is ability to stem trajectory for psychosis and bi-polar disorder [seek clarification] • Gerry Yorioka: look at 1) workforce needs – in terms of child psychiatrists; 2) use of telemedicine – is that something that UW uses for Hep C and chronic pain – rural areas don’t have resources for management • MaryAnne Lindeblad: There are three sub committees; will continue to look at things like workforce, increase child resources and residency; has been a fair amount of conversation on what workforce needs are; also talking about how resources can be used more effectively (telemedicine)

<ul style="list-style-type: none"> • PEBB adds schools to plans, called SEBB starting in 2020; HCA will oversee benefits for school teachers, which amounts to another 250K lives we will be covering in WA state; PEBB, SEBB, MED, all influence quality of access , etc. in state of WA; significant project will help determine who districts contract with for Healthcare • There is a new web page for providers on prior auth; we can send instructions for services that are not part of this [Action] • Apple Health books no longer in hard copy; HCA is no longer sending welcome packet; these will now be available online; it was a federal requirement with new federal managed care rules; there is a 1-800 number to get that information in hardcopy (for those without internet/computer access) • Preston Cody: The biggest advantages are dollar savings, and ability to get out in different languages • MaryAnne Lindeblad: This modernizes the program, and still allows for paper copy if needed • Claudia St. Clair: It has been a long time coming, a goal for many years • Regarding SEBB: Will there be FTEs associated with this ? • MaryAnne Lindeblad: Yes maybe 50 , much will be in customer service and part of our space challenge; we are not only adding new SEBB employees, but DBHR; significant challenge is how we will locate all staff in this corner of Olympia • Bob Perna: If not doing booklets, how will people know? • MaryAnne Lindeblad: People will receive a letter • MaryAnne Lindeblad: Sense of other things that came from new legislation; between work groups, committees, advisory groups; these are not whole new programs but a variety of things we have been 			

directed to do, with 47 new reports due between October and December; this gives you an idea of some pretty significant additional activity, without the benefit of new staff; gave examples from list which touches on a few things (Action-send list)

- CHMWG PAC islander Heath care
- COFA
- Can start purchasing through exchange – HCA does premium and cost share for them
- Partnering with WSDA and Oral Health Connections (in Jan 2019); provides new benefits for diabetes and pregnant women
- Autism Alliance
- Opioid issue
- Governor’s Indian/Native American Health Council
- Want to mention there was a vendor rate increase that the leg put through for certain PEDs codes; working closely with WAP in terms of how that will be implemented; challenges include update of codes-WAC – Effective Oct 1, but will encompass what that looks like; legislature put limits on monies; will keep you informed on that work
- Bob Perna: Regarding the vendor rate increase, what services will be impacted? Will it mirror previous bump in Medicaid?
- MaryAnne Lindeblad: Same as last bump that was through the ACA
- Andrew Busz: In terms of PEDs services, what is the age?
- MaryAnne Lindeblad: To age 18
