- November meeting change from 11/24/17 to 11/17/17

7. Managed Care Update | Lead: Claudia St. Clair

- Managed Care is in amendment 9; rather than going into great detail, if there is raised interest we can raise topic at the next in-person meeting
- Have sent a draft contract to the Managed Care Organizations (MCOs); gathering input from providers, stakeholder, etc.

- Most amendments are related to new regulations; there are slight revisions to refer to CFRs; mostly related to terms, conditions, rates and appeals
- Largest changes are in mental disease; effective July 1 in state of Washington, implementation process with MCOs is to keep enrolled while institutionalized
- There are funding gaps in federal participation; pleased to have found a solution
- After moving a significant number of clients in January 2017; number of clients are slightly higher than earlier projections; there will be a small rate reduction, with cost avoidance and recoupments
- Continuing to look at Request for Proposal (RFP) for North Central region; getting close to the evaluation process
- Topic is better suited for in person meeting; we can send a final list of all the changes at later date
- We are waiting for guidance from CMS; information that Preston Cody provided today may be subject to change depending on guidance that comes out; may loosen up what have been tight restrictions; must implement with what we have today [MaryAnne Lindeblad]
- Possible regulations could change over time; we will make adjustments as needed [Preston Cody]
- New leadership would be reviewing regulations that went into effect a few years ago
- Most have been Behavioral Health and Substance Use Disorder (SUD), which will see the most change; there is a Q&A in the works; primary care providers shouldn't see much of a change
- Additional state only expenditures are in the budget ; should be pretty transparent to the providers
- In addition to the managed care regulations last year, section on anti-discrimination will be updated (refer to 42 CFT 9; implementation of 1557 on anti-discrimination; implemented prior to this amendment)
- Clarify IMD = institution mental disease (old terminology) stated in regulations

#### 8. Legislative Update | Lead: MaryAnne Lindeblad

- We will hit bill highlights where we have the most interest; we can expand in person if group has an interest for greater detail
- **1713 Children's mental health** – Maintaining adequate provider network; not funded; addresses mother's depression; requires Behavioral Health Organizations (BHO) to pay for telemedicine; Office of the Superintendent of Public Instruction is providing pilots; no funds currently appropriated
- **5779 Behavioral health / primary care** - Also a behavioral health bill – integration into primary care; has to do with HCA going through and reviewing different codes; making sure identified codes, payment rules reflect how want that to be achieved; same day billing clarification; updating billing guides; behavioral health measure set; really making sure we have updated information what can and cannot be billed – partial veto when governor signed; rate increase to help providers; no appropriation
- **1819 Children's mental health** - Reduces paperwork with behavioral health providers
- **5079 Dental services for tribes** - First bill approved; pertains to dental health billing; allow tribes to use other dental mid-level providers; passed and waiting to hear from CMS
- **1388 Behavioral health integration**; legislation that moves Behavioral health to HCA, effective 1/1/18; funding and budget moves 7/1/17; amends language to provide for transition of BHOs to mid-adopter by 1/1/19; language provides for transition planned 1/2010-1/2020; a topic we will want to spend time on if it passes
- Other bills with areas of interest include: dental provider pilot; diabetes in pregnant women; adding hearing aids to benefit design

- **1616** Creates the Department of children and families; moving from Department of Social and Health Services to Department of Early Learning
- Will bring a list of bills with summaries that have impact on Medicaid in July; there are a few provisos about dental managed care; will see if they pass and bring summary if they do

9. AIM Update | Lead: Kirsta Glenn

- There are some Analytics, Interoperability and Measurement and data products that may be of interest to you
- Analytics, Interoperability, and Measurement (AIM) stands for: analytic tools, interoperable systems, and standardized measurement strategies
- Data is essential to achieving the Triple Aim of better health, better, care, and lower costs
- Good data drives better quality and consistency of care
- It helps us assess whether and how our strategies for health care improvement are working
- AIM goals include:
  1. Developing new data and analytic capabilities and providing technical assistance to support community population health management and local public health needs across Washington.
  2. Creating a comprehensive data infrastructure across state agencies that provides the opportunity for shared analytics to address health inequalities through smart, targeted initiatives.
  3. Providing accurate and actionable data for analysis and distribution to further delivery system transformation and payment reforms.
- Seven (7) staff support goals of Healthier Washington (HW) initiative; Information on both AIM and HW can be found on our website at [hca.wa.gov](http://hca.wa.gov)
- Emphasis is getting data out there; we will be testing for a few weeks; link from website should be available in a couple weeks
- Asked whether it permits interstate Medicaid communication; we have not heard anything about that as an emergency measure; at some point it may be worth a discussion
- It is a great user friendly resource for folks; technical documentation provides extra background
- We are building the dashboard over time, and would love to hear stakeholder input

10. Medicaid Demonstration Waiver Update | Lead: Marc Provence

- Not a lot of updates this time around; as folks know from previous discussions, we are developing a number of protocols and working on project tool kit, funding and mechanics protocols

- Protocols are all subject to CMS review and approval

- In terms of work with ACHs, we engaged services of Manatt in order to help develop organizational capabilities, develop and carry out projects, and develop project plans
- Require ACHs to go through multi-phase certification so can be successful in governing structure, engaging publics, relationships with tribes and providers; have met a milestone for submitting certification (applications); certifications occur in phases; this helps to make sure they have all components in place to be successful
- Manatt – is a national firm with offices on both coasts; work in transformation waivers with other states; brings multi state interaction and services; was a competitive procurement
- Initiative 3 – under waiver – third party administrator of benefits; it is a means of bringing providers on and ensure they are paid; proposals are being evaluated, with objective to have selection and services in place by 7/1/17
