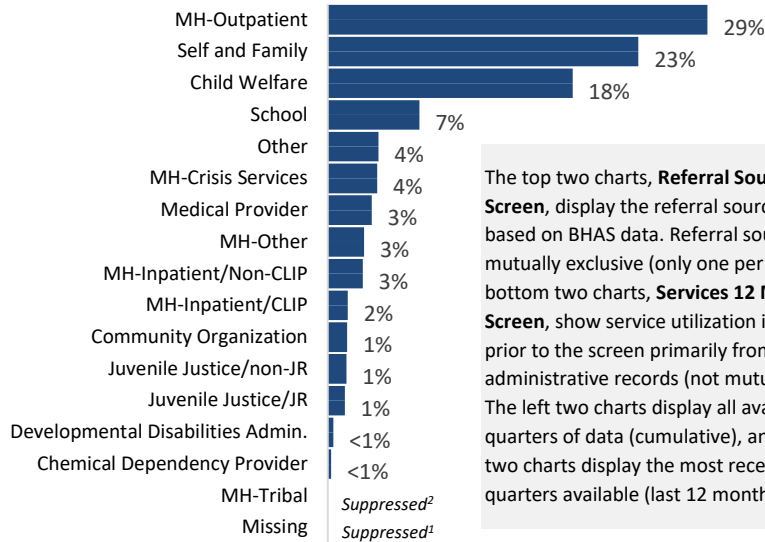

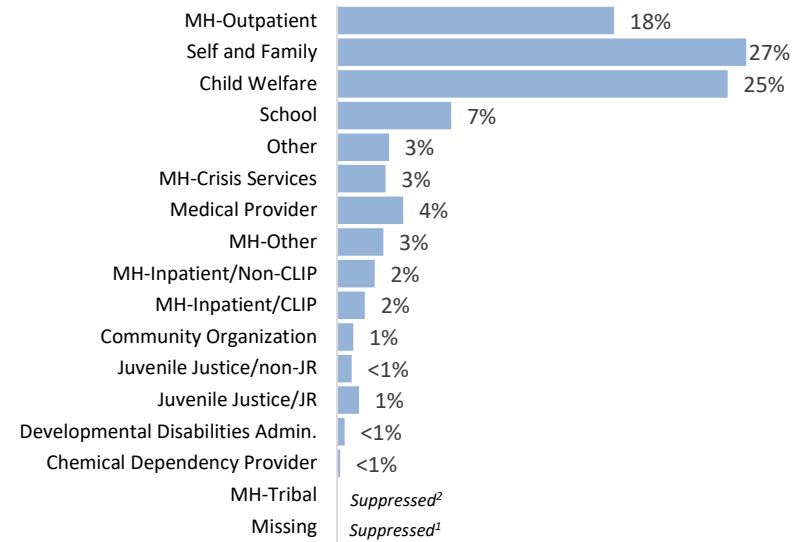

LAST 12 MONTHS October 2019 - September 2020

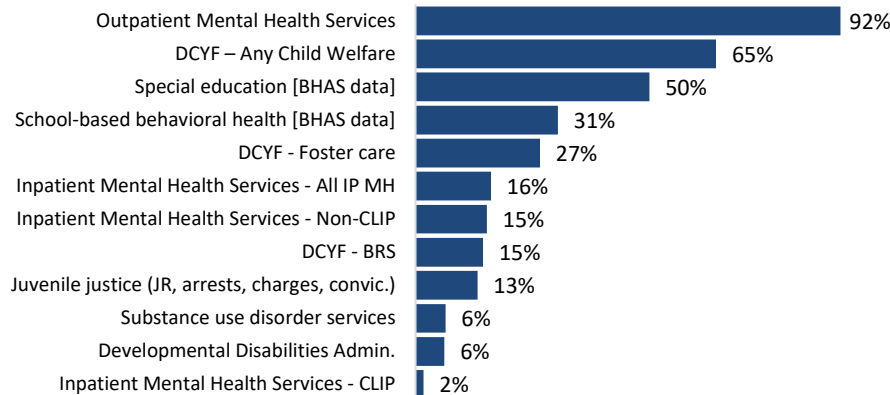

The left two charts display all available quarters of data (cumulative), and the right two charts display the most recent four quarters available (last 12 months).

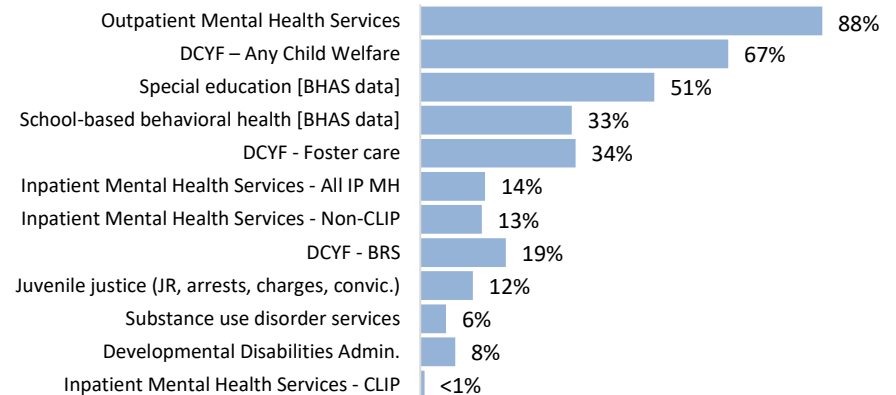
Services 12 Months Before Screen

LAST 12 MONTHS July 2019 - June 2020

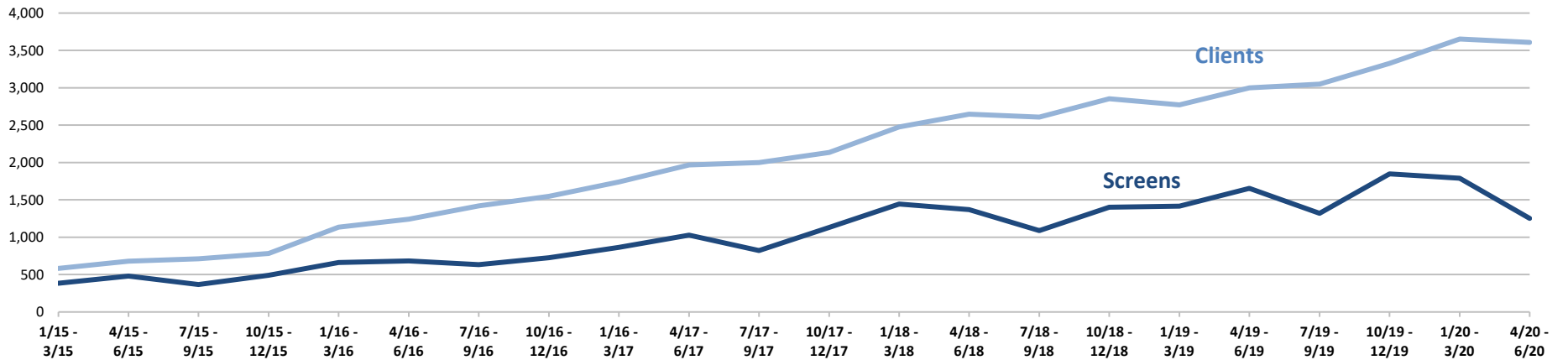
